JSE OF FABRIC ANGEL	Full Company, Technical Staff	M	Ensure that the fabric is secured properly and DSM is trained to operate it correctly.	Brief all members of the company and technical staff about the possible hazards when operating the fabric angel.		
JSE OF BRAMBLE AND OTHER THORNED PLANTS ON STAGE	Full Company, Technical Staff	L	Be aware of its presence and avoid over- handling them. If holding them, wear appropriate protection for your hands.			
CARRYING ACTORS ON STAGE ON A ROSTRUM.	Full Company	M	All Company members should be briefed on heavy lifting and should ensure the scene is well rehearsed.
